CERTIFICATE OF WATER RIGHT (In accordance with the provisions of Chapter 117, Laws of Washington for 1917, and the rules and regulations of the State Supervisor of Hydraulics thereunder.)

This is to certify, that Joe Szydlo and W. S. Gillard of Stevenson, State of Washington, ton, has made proof to the satisfaction of the State Supervisor of Hydraulics of Washington, of a right to the use of the waters of Wind River, a tributary of Columbia River, for the purposes of Irrigation under Appropriation Permit No. 3426 issued by the State Supervisor of Hydraulics, and that said right to the use of said waters has been perfect in accordance with the laws of Washington, and is hereby confirmed by the State Supervisor of Hydraulics of Washington and entered of record in Volume 4, at Page 1939, on the 14th day of July, 1943, that the right hereby confirmed dates from July 12, 1941; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually benefically used for said purposes, and shall not exceed 1.17 cubic feet per second.

A description of the lands under such right to which the water hereby confirmed is appurtenant, and the place where such water is put to beneficial use, is as follows:
