CLAIM OF LIEN

NOTICE IS HEREBY GIVEN that BOB SANFORD of Clatskanie, Columbia County, Oregon, claims a lien upon a quantity of mixed logs, being about 150,000 board feet in quantity, which were cut or manufactured in Skamania County, Washington, some of which are marked thus <sup>RD</sup> ON, and are now lying both on the property on which they were cut, which is a piece of property in the Northwest Quarter of Section 20, Township 3 North, Range 7 East, Willamette Meridian, and at the Wind River dump in Stevenson, Washington, for labor performed upon and assistance rendered in cutting, decking and hauling said logs and constructing a road for that purpose; that the name of the owner or reputed owner is AL WHITE dba C & W LUMBER COMPANY; that the said AL WHITE employed said BOB SANFORD to perform such labor and render such assistance upon the following terms and conditions, to-wit:

The said AL WHITE agreed to pay the said BOB SANFORD for such labor and assistance on the basis of logs cut, decked and hauled; that said contract has been faithfully performed and fully complied with on the part of said BOB SANFORD, who performed labor upon and assisted in cutting, decking and hauling said logs for the period between July 25, 1979 and September 3, 1979; that said labor and assistance were so performed and rendered upon said logs between the 25th day of July, 1979 and the 3rd day of September, 1979; and the rendition of said service was closed on the 3rd day of September, 1979, and thirty (30) days have not

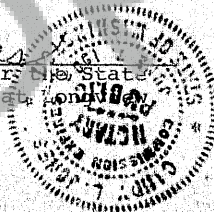
