Arthur Leonard Clift to Rhea May McKinney

Power of Attorney

KNOW ALL MEN BY THESE PRESENTS that I, Arthur Leonard Clift, temporarily residing in New Orleans, Louisiana, and legally domiciled in the City of Kalama, County of Cowlitz, State of Washington, and who is now in the active military service of the United States Army Serial No. 20 951 940, do hereby make, constitute and appoint Rhea May McKinney, my sister, at present residing in the City of Kalama, State of Washington, my true and lawful attorney, with full and complete authority, for me and in my name, place and stead, to act in, manage and conduct all my estate, property and affairs, and to do whatever is in said attorney's judgment proper and expedient in respect thereto; it being intended to hereby constitute said attorney my general attorney in fact, with such complete authority that said attorney can manage all of my affairs as if they were (her) own.

And without in any way limiting the above general grant of authority, my attorney is hereby expressly authorized to sell, mortgage, lease, and otherwise encumber or alienate, and to take possession and control, of any and all property belonging to me, real, personal or mixed, wherever situated, and to execute any and all documents or instruments necessary therefor; to execute vouchers in my behalf for any and all allowances and reimbursements properly payable to me by the United States, including but not restricted to allowances and reimbursements for transportation of dependents or for shipment of household effects as authorized by law and Army Regulations, and to receive, indorse and collect the proceeds of checks payable to the order of the undersigned, particularly those drawn on the Treasurer of the United States.

Further, I do authorize my aforesaid attorney-in-fact to perform all acts in the execution of the aforesaid authorizations which in (her) sole judgment may be necessary or desirable; and I do hereby expressly declare that the powers herein granted to my aforesaid attorney-in-fact shall not be construed as limited to those matters hereinbefore specifically set forth, but rather shall be construed to broadly include and embrace full and unlimited power and authority to do and perform, on my behalf and in my place and stead and with equal validity, any and all other lawful acts or things which I could do if personally present; hereby ratifying and confirming whatsoever my said attorney shall and may do by virtue hereof, in the premises.
