HONORABLE DISCHARGE FROM THE UNITED STATES ARMY

TO ALL WHOM IT MAY CONCERN:

KNOW YE, THAT STEPHEN D. ADKINS A PRIVATE OF THE U.S. MARINE CORPS, WHO WAS ENLISTED THE 2ND DAY OF APRIL, 1917, AT MARE ISLAND, CALIFORNIA, TO SERVE FOR THE DURATION OF THE WAR, IS HEREBY HONORABLY DISCHARGED BY SPECIAL ORDER OF THE MAJOR GENERAL COMMANDANT. FOR THE CONVENIENCE OF THE GOVERNMENT.

SAID STEPHEN D. ADKINS WAS BORN DECEMBER 13TH, 1895 AT HOPWELL, OREGON, AND WHEN ENLISTED WAS 67 1/2 INCHES HIGH, WITH BLUE EYES, BROWN HAIR, RUDDY COMPLEXION; OCCUPATION, LABORER; CITIZENSHIP, U.S. ACCEPTED FOR ENLISTMENT AT PORTLAND, OREGON.

GIVEN UNDER MY HAND AND DELIVERED AT MIAMI, FLORIDA, THIS 20TH DAY OF SEPTEMBER, 1919
