A tract of land located in the Northeast Quarter of the Southwest Quarter of Section 17, Township 3 North, Range 8 E.W.M., described as follows:

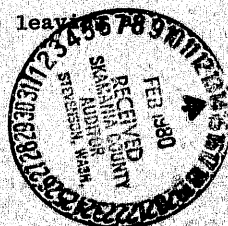
