CERTIFICATE OF WATER RIGHT

(In accordance with the provisions of Chapter 117, Laws of Washington for 1917, and amendments thereto, and the rules and regulations of the State Supervisor of Hydraulics thereunder.)

This is to certify, that GEORGE F. BRESLIN of Washougal, State of Washington, has made proof to the atisfaction of the State Supervisor of Hydraulies of Washington, of a right to use of the waters of an unnamed spring, a tributary of Columbia River, with point or points of diversion within the No of MET Sec. 16, Twp. 1 N. Range 5 E, W. M., for the purposes of domestic supply under appropriation Permit No. 4141 issued by the State Supervisor of Hydraulies, and that said right to the use of said waters has been perfected in accordance with the laws of Washington, and is hereby confirmed by the State Supervisor of Hydraulies of Washington and entered of record in Volume 5, atPage 2272, on the 2nd day of August, 1945; that the right hereby confirmed dates from April 16, 1945; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually benefically used for said purposes, and shall not exceed 0.01 of a cubic foot per second.

A description of the lands under such right to which the water heveby confirmed is appurtenent, and the place where such water is put to beneficial use, is as follows:
