


NOTICE OF CLAIM OF LIEN

NOTICE IS HEREBY GIVEN That on the 7th day of December, 1979, the above-named claimant at the request of Deborah Sullivan commenced to survey, establish and mark boundaries thereof, and/or prepare maps for the improvement of the following described property: A portion of S.M. Hamilton D.L.C. in Section 20, Township 2 North, Range 7 East, S.M., Skamania County, Washington, described as follows: COMMENCING at the intersection of the Northerly shore of Greenleaf Slough with the Easterly line of said Hamilton D.L.C.; then South 17° 30' East following the Easterly line of said D.L.C. to intersection with the Northerly right-of-way line of Primary State Highway No. 14; thence Westerly along the Northerly line of said highway 240 feet to the TRUE POINT OF BEGINNING; thence North 17° 30' West parallel to the Easterly line of said D.L.C. to a point South 17° 30' West 100 feet from the Southerly Shore of Greenleaf Slough said point being the South Easterly corner of that parcel of land described in a deed to W. Edward Cole recorded April 12, 1971 at Page 110 of Book 61, Skamania County Deed Records; thence Southwesterly along the Southerly line of said Cole tract to the Southwesterly corner thereof; thence North 17° 30' East to the North shore of the Greenleaf Slough; thence Southwesterly along the North line of the Greenleaf Slough to the intersection with the North right-of-way line State Highway No. 14; thence Easterly along said North right-of-way line to the TRUE POINT OF BEGINNING. EXCEPT that parcel described in a Real Estate Contract recorded J. 14 16, 1970 on Page 383 of Book 61, Skamania County Deed Records, and except that parcel described in a Warranty Deed Recorded September 1, 1977 on Page 411 of Book 73, Skamania County Deed Records.

In Skamania County, State of Washington, of which property the owner, or reputed owner is Vista Realty, Inc.

The performance of labor, furnishing of material or supplying of equipment ceased on April 17, 1980. The name of the corporation which supplied the labor furnished the material or supplied the equipment was Hagedorn, Inc. and the person to whom the material was furnished, equipment supplied or labor performed was Vista Realty, Inc. and Deborah Sullivan. The value of the labor performed, material furnished or equipment supplied was \$ 1725.00. The amount of lien claimed is \$ 1243.50 plus interest at 12 percent per annum from April 30, 1980 until paid.
