

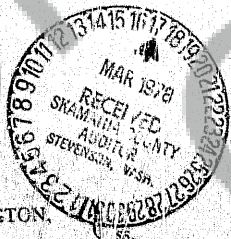
## NOTICE OF CLAIM OF LIEN

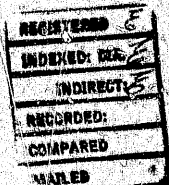
