The tax amount herein shall be due and payable to the County Treasurer on or before April 30, 1981. The tax shall become a lien on this land and shall be subject to foreclosure in the same manner as provided in RCM 84-04-054, and shall be charged interest at the same rate as applied by law to delinquent ad valorem taxes from the due date shown above.
