KNOW ALL MEN BY THESE PRESENTS, That in consideration of One Dollar (\$1.00) and other valuable consideration, receipt whereof is hereby acknowledged, I, W. E. BUELL, do hereby grant by way of quitclaim to the Skemania County Public Utility District No. 1, its successors and assigns, the right to lay, maintain, operate, repair and remove the following water pipe line through and over the following described real property:

The Northeast Quarter of Section 23, Township 3 North, Range 10 East, W.M. situated in the County of Skamania, State of Washington,

Said pipe line shall be laid according to the following course:

Beginning at a point on the east line of the County Road along the west line of said Northeast Quarter approximately 280 feet south of the center line of the County Road which bounds the north line of said Northeast Quarter; thence easterly in a line parallel to said County Road bounding the north line of said Northeast Quarter to the east line of said Northeast Quarter.

The said pipe line shall be laid approximately 30 inches deep. It is provided that the Grantee may make reasonable variations from the straight line across the property above described as may be necessitated by rock encountered in laying the line.

In accepting said right of way the Grantee agrees to indemnify and hold harmless the Grantor, his heirs and assigns, from liability for damages to third persons arising out of the installation, operation, maintenance or repair of said pipe line, and agrees to re-imburse the Grantor for all damages to the above described property arising out of the installation, operation, maintenance, repair or removal of said pipe line.

TO MAVE AND TO HOLD unto the Skamania County Public Utility District No. 1, its successors and assigns, the right to maintain and operate said pipe line forever, so long as said pipe line is used for delivering water to the above described property.
