The undersigned, hereinafter called the Customer, as all of the owners and/or tenants of the hereinafter described property, hereby request Fublic Utility District No. 1 of Skamania County, Washington (hereinafter called the District) to extend its water distribution system by laying mains as nearly adjacent as practicable to the customer's property, described at the bottom of this paragraph, to install connections from the Customer's premises to said system, and to supply water for use on said property, to-wit: Legal Description of Property:

West Half of Morthwest quarter of Sec. 20, NW quarter of SW quarter Sec. 20. Above description is to correct description on File Record 36329 of Jan. 22, 1947 Twp. 3 Range 10 E.W.M.

In consideration therefor, and in addition to the payment of such rates or charges for water as may hereafter be fixed by the District, the customer agrees to pay the District the sum of Six Hundred Dollars. Said sum may be paid in full, without interest, on the first day of the month succeeding the month in which the District is ready and able to furnish the Customer with water, or may be paid on the first day of each month in installments of Twenty-Five Dollars, or any multiple thereof, commencing on the same date. If said sum is paid in installments, the unpaid balance shall bear interest at the rate of  $3\frac{1}{2}\%$  per annum commencing with the same date, and said interest shall become due and payable at the same time said installments become due and payable; provided, said balance may be raid in full at any time, with interest at the same rate to the date of such payment.

If any payment herein provided for is not paid en due, the District may shut the water
