KNOW ALL MEN BY THESE PRESENTS: That W. G. Strachan the undersigned (jointly and severally, if more than one) hereby make, constitute and appoint Nellie G. Strachan my true and lawful Attorney for me and in my name, place and stead and for my use and benefit:

- (a) To ask, demand, sue for, recover, collect ar receive each and every sum of money, debt, account, legacy, bequest, interest, dividend, annuity and demand (which now is or herrafter shall become due, owing or payable) belonging to or claimed by me, and to use and take any lawful means for the recovery thereof by legal process or otherwise, and to execute and deliver a satisfaction or release therefor, together with the right and power to compromise or compound any claim or demand;

- (d) To borrow money and to execute and deliver negotiable or non-negotiable notes therefor with or without security; and to loan money and receive negotiable or non-negotiable
 notes therefor with such security as he shall deem p oper;
