## DRIFT AGREEMENT

WHIREAS, OSCAR HEDBOM, who has been drift fishing on the Columbia River, between the City of Hood River, Oregon, and Mitchell Point for the last five years, and

WHEREAS, JOHN SHARF has been drift fishing on the said Columb.a River at or about Hood River. Oregon, for the last three years, and

WHEREAS, C. H. ULLRICH has been drift fishing on the Columbia River at or about Hood River for the last year, and

WHEREAS, H. W. ITEPHENSON has, during the current year, been drift fishing on the said COLUMBIA RIVER at or about Hood River, and

WHEREAS, said Parties are desirous of pooling their joint efforts for their common good in drift fishing, and

WHEREAS, that can best be accomp? ished by the organization of a "Drift Area",

NOW, THEREFORE, IT IS HEREHY AGREED by and between the parties hereto that a Drift Area to be known as the "Flume Drift" shall be organized and we, the undersigned, do hereby associate surselves together for that purpose.

FIRST: The name of the "Drift" shall be the "Flume Drift".

SECOND: The Flume Drift shall be located on the Columbia River on the Urwgen and Washiggen side thereof between the West end of Wells's Island and Mitchell Point.

THIRD: The principal office of said Drift shall be in Heod Flyer, Oregon

FOURTH: The term of this association small be unlimited.

FIFTH: All rights of property and otherwise that may accrue by reason of this association shall be shared in equally by all members of said Brift.

SIXTH: There shall be a captain and secretary of said Drift who shall vewert annually to the members of the Drift at the annual meeting thereof on the first Monday in April of each year.

SEVENTH: It is hereby understood that the drift is a cooperative non-profit enterprise for the individual benefit of each member.
