ARNOLD, FOR AND IN CONSIDERATION OF THE SUM OF ONE DOLLAR TO HIM IN HAND PAID DOES HEREBY TRANSFER, ASSIGN AND SET OVER UNTO COLUMBIA POWER AND INVESTMENT COMPANY, A CORPORATION, ALL HIS RIGHT, TITLE AND INTEREST IN AND TO THOSE TWO CERTAIN FRANCHISES OR EASEMENTS GRANTED UNTO THE SAID W. A. ARNOLD BY TOWN OF STEVENSON, AND SKAMANIA COUNTY, WASHINGTON, RESPECTIVELY FOR THE USE OF CERTAIN STREETS AND ROADS FOR POWER AND LIGHT TRANSMISSION LINES, MORE PARTICULARLY DESCRIBED THEREIN, WHICH SAID FRANCHISES WERE AS FOLLOWS, TO-WIT:

WE, THE UNDERSIGNED, BEING THE OWNERS AND CONTRACTEE OF THE PROPERTY HEREIN DESCRIBED, DO, IN CONSIDERATION OF THE BENEFITS AND ADVANTAGES TO ACCRUE TO US BY THE LOCATION AND ESTABLISHMENT OF THE ABOVE PROPOSED COUNTY ROAD, HEREBY CONSENT THAT SAID ROAD BE ESTABLISHED AS DESCRIBED IN THE PETITION AND AS EXAMINED AND SURVEYED, AND FOREVER RELINQUISH TO SKAMANIA COUNTY, WASHINGTON, A RIGHT-OF-WAY 40 FEET IN WIDTH OVER AND ACROSS THE FOLLOWING DESCRIBED PIECE OR PARCEL OF LAND, TO-WIT:

LOTS THREE (3) AND FOUR (4) AND THE SE $\frac{1}{4}$ OF THE SW $\frac{1}{4}$ AND THE S $\frac{1}{2}$ OF THE NE $\frac{1}{4}$ OF THE SW $\frac{1}{4}$ OF SECTION THIRTY-ONE (31), TOWNSHIP TWO (2) NORTH RANGE SIX (6) E OF THE WILLAMETTE MERIDIAN,

SAID ROAD TO BE LOCATED ACCORDING TO THE DIRECTION OF THE COUNTY COMMISSIONERS OF SKAMANIA COUNTY, WASHINGTON, AND TO RUN FROM THE SMITH AND CRUPE ROAD, NEAR OR WHERE THE PRESENT ROAD LEADING TO THE HARVEY QUAIL PROPERTY IS NOW LOCATED.
