POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: That RECONSTRUCTION FINANCE COPPORATION, acorporation organized and existing under and by virtue of an Act of Congress entitled "RECONSTRUCTION FINANCE CORPORATION ACT", approved January 22, 1932, hereby and by these presents does make constitute, and appoint JAMES H. CRUICKSHANK, OF THE CITY OF OSWEGO, COUNTY OF CLACKAMAS, STATE OF OREGON, its true and lawful attorney for it and in its name and stead:

- l. To sell, lease or sublease, and enter into contracts for the vale, lease or sublease of any real estate, chattels, or interests therein, held by Reconstruction Finance Corporation; and t. assign leases and subleases of any real estate, chattels or interests therein, held by Reconstruction Finance Corporation.

This is to certify, that CARL L. NIELSEN of Cock, State of Washington, has made proof to the satisfaction of the State Supervisor of Hydraulics of Weshington, of a right to the use of the waters of an unnamed spring, a tributary of Rock Creek, with point or points of diversion within Block 12, Lot 1, Manzanola Orghard Tragts Sec. 10, Twr. 3 N., Range 9 E. W. M., for the purposes of domestic supply under Appropriation Permit No. 4921 issued by the State Supervisor of Hydraulics, and that said right to the use of said waters has been perfected in accordance with the laws of Washington, and is hereby confirmed by the State Super visor of Hydraulics of Washington and antered of record in Volume 7, at Page 3383, on the 26th day of September, 1949; that the right hereby confirmed days from December 5, 1946; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.CL of a cubic foot per second
