

At Brower to James Driscoll

Know all men by these presents that I, August Brower of Skamania County, State of Oregon, the party of the first part, for and in consideration of Nineteen hundred and $\frac{1}{2}$ (1900 $\frac{1}{2}$) Dollars, gold coin of the United States of America, to me in hand paid by James Driscoll of Portland, Oregon, the party of the second part, Thence, the receipt of which is hereby acknowledged, have granted, bargained, sold, engaged and transferred and by these presents do grant, bargain, sell, engage and transfer unto the party of the second part, a certain Indenture of Mortgage, bearing date the 20th day of April A.D. 1907, made and executed by Harry Wacker and Maggie Wacker, his wife, of Skamania Co. Wash. to the said party of the first part, to secure the payment of the sum of Thirty nine hundred $\frac{1}{2}$ \$ $\frac{1}{2}$ (3900. $\frac{1}{2}$) together with the note or obligation therein described and the money due or to grow due thereon, with the interest, which said mortgage was recorded in the office of the Recorder of County of Skamania, State of Washington in Book "G" of mortgages, page 493. on the 24th day of April A.D. 1907.

To have and to hold the same unto the said party of the second part, his executors, administrators or assigns for his use and benefit, subject only to the provisions in the said Mortgage mentioned. And the said party of the first part does hereby covenant to and with the said party of the second part, that he is the lawful owner and holder of said Note and Mortgage and that he has a good right to sell, transfer and assign the same as aforesaid, and that there is now due and owing upon said note and Mortgage the sum of Nineteen hundred $\frac{1}{2}$ \$ $\frac{1}{2}$ (1900. $\frac{1}{2}$) Dollars with interest from the 20th day of April A.D. 1907.
