This is to certify that MAE'S. WEDRICK of nome Valley, State of Washington, has made proof to the satisfaction of the State Supervisor of Water Resources of Mashington, of a right to the use of the waters of an unnamed stream, a tricutary of Columbia River, with point or points of diversion within the NEL of SEL of Sec. 27, Twp. 3 N., R. 8 E., W.
