CERTIFICATE OF SURFACE WATER RIGHT. Certificate Record No. 9, Page No. 4303
State of Washington, County of Skamania.
This is to certify that FRANK WM. BIRKENFELD of Home Valley, State of Washington, has made proof to the satisfaction of the State Supervisor of Water Resources of Washington, of a right to the use of the waters of unnamed stream, a tributary of Columbia River, with point or points of diversion within the NW $\frac{1}{4}$ of SE $\frac{1}{4}$ of Sec. 27, Twp. 3 N., R. 8 E., W.M., under and subject to provisions contained in Appropriation Permit No. 6294 issued by the State Supervisor of Water Resources, and that said right to the use of said waters has been perfected in accordance with the laws of Washington, and is hereby confirmed by the State Supervisor of Water Resources of Washington and entered of record in Volume 9, at Page 4303, on the 22 day of October, 1951 that the priority date of the right hereby confirmed is July 17, 1947; that the amount of water under the right hereby confirmed, for the following purposes is limited to an amount actually beneficially used and shall not exceed 0.03 of a cubic foot per second for the purpose of irrigation of 7.6 acres and domestic supply
A description of the lands under such right to which the water right is appurtenant, and the place where such water is put to beneficial use, is as follows:
Commencing at a point 10 chains East and 1320 ft. North of the intersection
