CERTIFICATE OF SURFACE WATER RIGHT

This is to certify that UNITED STATES FISH AND WILDLIFE SERVICE of Portland, State of Oregon, has made proof to the satisfaction of the State Supervisor of Water Resources of Washington, of a right to the use of the waters of Little White Salmon River, a tributary of Columbia River, with point or points of diversion within the NW $\frac{1}{4}$ of NE $\frac{1}{4}$ of Sec. 26, Twp. 3 N., R. 9 E., W.M., under and subject to provisions contained in Appropriation Permit No. 6042 issued by the State Supervisor of Water Resources, and that said right to the use of said waters has been perfected in accordance with the laws of Washington, and is hereby confirmed by the State Supervisor of Water Resources of Washington and entered of record in Volume 10 at Page 4505, on the 28th day of January, 1952 that the priority date of the right hereby confirmed is March 8, 1949; that the amount of water under the right hereby confirmed, for the following purposes is limited to an amount actually beneficially used and shall not exceed 34.40 cubic feet per second for the purposes of artificial propagation and rearing of anadromous fish.

A description of the lands under such right to which the water right is appurtenant, and the place where such water is put to beneficial use, is as follows:

SE $\frac{1}{4}$ of NW $\frac{1}{4}$ of Sec. 26, Twp. 3 N., Rge. 9 E.W.M.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described, except as provided in Section 6 and 7, Chapter 122, Laws of 1929.

THIS IS TO CERTIFY That TOWN OF NORTH BONNEVILLE of North Bonneville, Washington, has made proof to the satisfaction of the State Supervisor of Water Resources of Washington, of a right to the use of the ground waters of a well located within the SE $\frac{1}{4}$ of NE $\frac{1}{4}$ of Sec. 21, Twp. 2 N., Rge. 7 E.W.M. for the purpose of municipal supply under and subject to provisions contained in Ground Water Permit No. 783 issued by the State Supervisor of Water Resources and that said right to the use of said ground waters has been perfected in accordance with the laws of Washington, and is hereby confirmed by the State Supervisor of Water Resources of Washington and entered of record in Volume 3 at page 1028-A; that the right hereby confirmed dates from March 22, 1947; that the quantity of ground water under the right hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 378 gallons per minute; 470 acre-feet per year.

A description of the lands to which such ground water right is appurtenant, and the place where such water is put to beneficial use, is as follows:
