CERTIFICATE OF SURFACE WATER RIGHT

This is to certify that H. L. Waldorf of Home Valley, State of Washington, has made proof to the satisfaction of the State Supervisor of Water Resources of Washington, of a right to the use of the waters of unnamed stream and 2 springs, with point or points of diversion within the Jos. Robbins D.L.C. of Sec. 27, Twp. 3 N., R. 8 E., W. M., under and subject to provisions contained in Appropriation Permit No. 7455 issued by the State Supervisor of Water Resources, and that said right to the use of said waters has been perfected in accordance with the laws of Washington, and is hereby confirmed by the State Supervisor of Water Resources of Washington and entered of record in Volume 10, at Page 4608, on the 10th day of April, 1952 that the priority date of the right hereby confirmed is May 3, 1951; that the amount of water under the right hereby confirmed, for the following purposes is limited to an amount actually beneficially used and shall not exceed 0.02 of a cubic foot per second for the purpose of domestic supply.

A description of the lands under such right to which the water right is appurtenant, and the place where such water is put to beneficial use, is as follows:

COMMENCING at a point 924 feet East and 991 feet North of intersection of the West boundary of Jos. Robbins Donation Land Claim with South line of Sec. 27, Twp. 3 N., Rge. 8 E.W.M., said point of beginning being on Easterly line of tract of land conveyed to G. J. Wallingford by Ches. Davison, et ux; thence South 100 feet; thence West 244 feet more or less to Easterly line of Wallingford Road; thence Northerly along road to a point due West of point of beginning; thence East 230 feet more or less to point of beginning.

COMMENCING at a point 10 chains East and 682 feet North of intersection of West boundary of Jos. Robbins Donation Land Claim with South line of Sec. 27; thence North 209 feet; thence East 418 feet; thence South 209 feet; thence West 418 feet to place of beginning. Excepting easements for roads.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described, except as provided in Sections 6 and 7, Chapter 122, Laws of 1929.
