CERTIFICATE OF SURFACE WATER RIGHT

This is to certify that CLARENCE E. & ALISON O. BOYLE of North Bonneville, State of Washington, has made proof to the satisfaction of the State Supervisor of Water Resources of Washington, of a right to the use of the waters of an unnamed stream, a tributary of Columbia River with point or points of diversion within the NW $\frac{1}{4}$ of NE $\frac{1}{4}$ of Sec. 11, Twp. 1 N.R. 5 E., W.M., under and subject to provisions contained in Appropriation Permit No. 7074 issued by the State Supervisor of Water Resources, and that said right to the use of said waters has been perfected in accordance with the laws of Washington, and is hereby confirmed by the State Supervisor of Water Resources of Washington and entered of record in Volume 11, at Page 5227, on the 2nd day of June, 1953 that the priority date of the right hereby confirmed is December 2, 1950; that the amount of water under the right hereby confirmed, for the following purposes is limited to an amount actually beneficially used and shall not exceed

0.01 of a cubic foot per second for the
purpose of domestic supply.
