RUSSELL OF HOOD RIVER STATE OF OREGON, HAS MADE PROOF TO THE SATISFACTION OF THE STATE SUPERVISOR OF HYDRAULICS OF WASHINGTON, OF A RIGHT TO THE USE OF THE WATERS OF BUNKER CREEK A TRIBUTARY OF LITTLE WHITE SALMON R.
