



The Northwest Quarter of the Southeast Quarter ($NW\frac{1}{4} SE\frac{1}{4}$) of Section 11, Township 2 North, Range 5 E. W. M.; the Northwest Quarter of the Northwest Quarter ($NW\frac{1}{4} NW\frac{1}{4}$) of Section 14, Township 2 North, Range 5 E. W. M.; and a tract of land consisting of 4.6 acres, more or less, in Section 36, Township 3 North, Range 7 $\frac{1}{2}$ E. W.
