## Order Vacating Road

IN THE MATTER OF THE PETITION  
OF M. MONTCHALIN AND OTHERS FOR  
THE VACATION OF PART OF STATE  
ROAD NO. 8.

This matter coming on regularly for hearing this 8th day of November, 1927, at 11:00 o'clock A. M., was postponed until 2:00 o'clock P. M. of the same day, and the Board finding,

First, That the petition therefor had been filed, and that said petition was signed by at least ten freeholders of the county, residing in the vicinity of the said road.

Second, That on the 6th day of September 1927, the County Engineer had been directed to examine said road and to make a report in writing thereon, and that on October 3d 1927, the County Engineer did file in the office of the Board his report in writing as provided by law.

Third, That by an order duly passed by this Board on October 4th, 1927, the 8th day of November was set for hearing the report of the Engineer and the consideration thereof, and that notice of said hearing was given by publication and posting as provided by law.

Fourth, That said report of the County Engineer shows; That in his opinion said road should be vacated for the reason that it is not necessary and that there is no longer any use for same, and the Board having examined all papers on file in the proceedings, and heard all testimony for the vacation of said road, and there being no objection to said vacation, and being satisfied that said road will not be useful as a part of the general road system.

IT IS ORDERED, all members concurring, that that portion of State Road No. 8 petitioned to be vacated by M. Montchalin et al be vacated.

Location of said road described as follows, to-wit:

Being all roads and trails on lot 13 of Sec. 36, T 3, Range 7 1/2 E. W. M. outside of the rights of way of the present State Road No. 8 and the present Nelson Creek Road as the same is now located and used. And more especially that portion of old right of way forming a triangle in said lot 13 in S. W. corner thereof and adjoining the present new right of way of said State Road No. 8.
