That plaintiff and defendant were lawfully married to each other in Skamania County, Washington Territory on the 25th day of December 1876; That on or about the month of July 1885, defendant ordered and drove the plaintiff from her house, and would not permit plaintiff to return to her home and live with him, and abused and called plaintiff vile names and charged her with being unchaste and threatened to kill plaintiff; That defendand has wholly failed and neglected to provide anything for the support and maintainance of plaintiff for Eighteen months last past.

It is therefore adjudged and decreed that the marriage contract now existing between plaintiff and defendant be and the same is hereby dissolved, annulled and held for naught, and that plaintiff recover her costs.
