Day, Jr. his heirs and assigns forever: and the title to the foregoing described premises, and every part thereof the said ourselves and our heirs and legal representatives to fence, warrant and defend unto the said J. C. Day, Jr. and to his heirs, assigns and legal representatives against the lawful claims of all persons claiming or to claim, the same or any part thereof.
