

B. A. Haffey & wife to Henry Weishard

This Indenture, Made this fifth day of September, A. D. 1903 by and between B. A. Haffey and Clencie E. Haffey < husband and wife > of the County of Multnomah, State of Oregon, parties of the first part, and Henry Weishard, also of the County of Multnomah State of Oregon, party of the second part, Witnesseth, That the said parties of the first part, for and in consideration of the sum of Six Hundred <\$600.00> Dollars to them in hand paid, the receipt whereof is hereby acknowledged, have bargained and sold, and by these presents do bargain, sell and convey unto the said party of the second part, his heirs and assigns, forever, all the following bounded and described property, to-wit: The South half of the South East quarter of Section Thirty-two <32> in Township Two <2> North of Range five <5> East of the Willamette Meridian containing eighty acres. Also the South West quarter of the North East quarter of Section four <4> in Township one <1> North of Range five <5> East of Willamette Meridian, excepting therefrom the East half of the East half of said South West quarter of the Northeast quarter, the amount of land hereby conveyed being Thirty <30> acres. Also commencing at the Northwest corner of the Real estate of the estate of William Haffey, Deceased, running thence south, along the west line of said real estate, of said estate Eighty-four <84> rods and sixteen <16> links to the north west corner of that portion of real estate set off or apportioned out of said estate of James Haffey, thence East along the North line of that portion of real estate set off or apportioned out of said estate aforesaid, to the west line of that portion of real estate set off or apportioned out of said estate of to Frank Haffey, thence North along said line of said real estate to set apart or apportioned to said Frank Haffey to the North line of said estate, thence west along said north line of said estate to the place of beginning, said described real estate containing $17\frac{1}{5}$ acres, more or less, and being a portion of the real estate, of said estate, situated in Skamania County, Washington. Also commencing at the Southeast corner of the Homestead heretofore set apart by order of Court for the use of Mrs Catherine Haffey and her minor child, and run thence East along the south line of the real estate belonging to the estate of William Haffey, Deceased, eighty <80> rods and sixteen <16> links to the Southeast corner of said real estate belonging to said Estate, thence North along the East line of said real estate belonging to said Estate Thirty-nine <39> rods and nine <9> links, thence West Twenty <20> degrees and thirty <30> minutes eighty <80> rods and sixteen <16> links to the east line of said Homestead, thence South along the East line of said Homestead thirty-nine <39> rods and nine <9> links to the place of beginning. Said described property containing Twenty <20> acres and being in Section 4 Tps 1 N. R. 5. E. of the Willamette Meridian and being a portion of the real estate of said estate. Also commencing at a point just on the Northeast corner of a portion of land owned by Bernard A. Haffey, < said point being on the East line of the real estate of William Haffey, Deceased, thirty-nine <39> rods and nine <9> links North of the Southeast corner of said estate > thence North along the East line of the Estate
