

NOTICE OF TAX LIEN UPON REAL PROPERTY

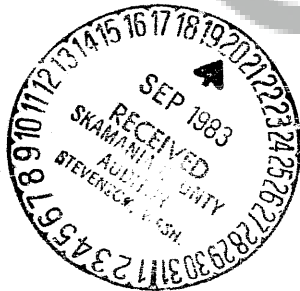
\* penalties, interest and costs will accrue at the statutory rate after this date.
