

You are hereby notified that the following land has been approved for XX classification under RCW 84.33.120. or designation under RCW 84.33.130 and 140 263.05 acres in Section 24, Township 7N Range 6E

North of the Lewis River 7-6-1104

FOREST LAND means and is synonomus with timberland and means all lands in any contiguous ownership of 20 or more acres, which is primarily devoted to and used for growing and harvesting timber and means land only.

CLASSIFIED is land whose highest and best use is the growing and harvesting of timber.

DESIGNATED is land which is primarily devoted to and used for growing and harvesting timber but whose value for other purposes may be greater than its value for use as forest land.

Upon removal of classified or designated forest land a compensating tax shall be imposed upon the land based on the following procedure:

The compensating tax shall not be imposed if the removal resulted solely from: (A) Transfer to government entity in exchange for other forest land; (B) A taking or transfer to entity having power of eminent domain; (C) Sale or transfer of land with-in two years after death of owner owning at least fifty percent (50%) interest in the land.
