

You are hereby notified that the following land has been approved for 🔀 classification under RCW 84.33.120, or 🗌 designation under RCW 84.33.130 and 140 All of Section 26 lying N of Swift Creek meander line and the SE-SW of section 23, Township 7N Range 5E. 145 acres 7-5-2800

FOREST LAND means and is synonomus with timberland and means all lands in any contiguous ownership of 20 more acres, which is primarily devoted to and used for growing and harvesting timber and means land only.

CLASSIFIED is land whose highest and best use is the growing and harvesting of timber.

DESIGNATED is land which is primarily devoted to and used for growing and harvesting timber but whose value for other purposes may be greater than its value for use as forest land.

Upon removal of classified or designated forest land a compensating tax shall be imposed upon the land based on the following

Number of Years in Designation Not to Exceed 10 Years and Classified Not to be Assessed True and Fair Classified Forest Land Value at Time of Removal MULTI-Last Levy Rate Extended Against Land Value of Land at Time of Removal MULTI LESS PLIED PLIED EQUALS Compensating Tax BY BY Prior to 1975 Recording Fee + Total Tax Due =

The compensating tax shall not be imposed if the removal resulted solely from: (A) Transfer to government entity in exchange for other forest land; (B) A taking or transfer to entity having power of eminent domain; (C) Sale or transfer of land within two years after death of owner owning at least fifty percent (50%) interest in the land.
