CERTIFICATE OF WATER RIGHT.

( for rights perfected under the original,enlargement or secondary permits)

(In accordance with the provisions of chapter 117,Laws for 1917,and the regula-  
tions of the State Hydraulic Engineer thereunder)

This is to certify,that Spokane,Portland & Seattle Ry,Co, of Portland  
State of Oregon,has made proof to the satisfaction of the State Supervisor of Hydraulics  
of Washington,of the right to the use of the waters of Dog Creek a tributary of Columbia  
River,for the purposes of domestic use and locomotive supply under appropriation Permit  
No.1240,of the State Supervisor of Hydraulics, and that said right to the use of said  
waters has been perfected in accordance with the laws of Washington,and is hereby con-  
firmed by the State Supervisor of Hydraulics of Washington and entered of record in  
Volume 1,at page 324,on the 19th day of April,1929;that the right hereby confirmed dates  
from November 5th,1928;that the amount of water to which such right is entitled and here-  
by confirmed,for the purposes aforesaid,  
is limited to an amount actually beneficially used for said purposes,and  
shall not exceed 0.50 cubic feet per second.

A description of the lands under such right,and to which the water hereby confirmed  
is appertenant,or if for other purposes,the places where such water is put to beneficial  
use,is as follows:Township 3 N.Range 9 E.W.M.section 34 lot 3.

The right to the use of the water aforesaid hereby confirmed is restricted to the  
lands or place<sup>of</sup> use herein described,except as provided in Section 39,Chapter 117,session  
laws 1917.
