That said Contract has been faithfully performed and fully complied with on the part of the Claimant, who performed labor upon and assisted in the logging, removal and hauling of said logs for the period from July 31, 1984 through August 6, 1984, and thirty (30) days have not elapsed since said time. That the amount of Claimant's demand for said services is the sum of \$19,061.90, in which amount he claims a lien upon all of said logs to secure payment for the work performed in obtaining or securing said logs, piles or other timber or products manufactured therefrom as herein described.

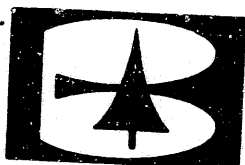

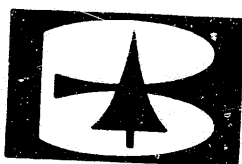
