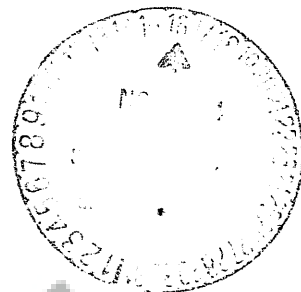

Notice is hereby given that **AJAY TRUCKING, INC.** of Multnomah County, State of Oregon, claims a lien upon a quantity of timber and saw logs, being about 14.4 million Board Feet in quantity, which are to be cut or manufactured in Skamania County and Klickitat County, State of Washington, are to be marked when cut thus: G-6 in yellow paint under a keystone shape, and are now standing in the Beaver sale area in Township 5, Skamania and Klickitat County, State of Washington, and to be taken when cut to the SDS rollout in Bingen, Washington, Broughton rollout in Cook, Washington; and Husum Multiple in Husum, Washington, for labor performed upon and assistance rendered in rocking the access road to timber and saw logs; that the name of the owner or reputed owner is Crown Zellerbach, Inc., that Columbia Properties, contractor for Crown Zellerbach, Inc. employed said **AJAY TRUCKING, INC.** to perform such labor and render such assistance upon the following terms and conditions, to wit:

The said Columbia Properties agreed to pay the said Ajay Trucking, Inc. for such labor and assistance \$48.00 per hour, per truck including fuel; that said contract has been faithfully performed and fully complied with on the part of said Ajay Trucking, Inc. who performed labor upon and assisted in rocking the access road to timber and said saw logs for the period of September 26, 1984 through October 17, 1984; and the rendition of said service was closed on the 17th day of October, 1984, and thirty days have not elapsed since that time; that the amount of claimant's demand for said service is \$9,100.00 that no part thereof has been paid, and there is now due and remaining unpaid

thereon, after deducting all just credits and offsets, the sum of \$9,100.00, in which amount he claims a lien upon said timber and saw logs. The said Ajay Trucking, Inc. also claims a lien on all said timber and saw logs now owned by said Crown Zellerbach, Inc. and Columbia Properties, of said county to secure payment for the work and labor performed in obtaining or securing the said logs, herein described.
