Notice is hereby given that **MARK G. STACY** of Skamania County, State of Washington, claims a lien upon a quantity of rough cut dimensional lumber, being about 55,000 board feet in quantity, which has been manufactured in Skamania County, State of Washington, from saw logs marked when cut thus: PSP, and said lumber is now lying in the yard of Horizons Forest Products, Inc. at the Carson, Washington Industrial Site in Skamania County, State of Washington, and to be taken to the yard of Puget Sound Plywood, Inc. in Tacoma, Washington, for labor performed upon and assistance rendered in pulling green chain, clean-up and other labor to said lumber; that the name of the owner or reputed owner of said lumber is Puget Sound Plywood, Inc., that Horizons Forest Products, Inc., contractor for Puget Sound Plywood, Inc., employed said **MARK G. STACY** to perform such labor and render such assistance upon the following terms and conditions, to wit:

The said Horizons Forest Products, Inc. agreed to pay the said Mark G. Stacy for such labor and assistance \$5.00 per hour; that said contract has been faithfully performed and fully complied with on the part of said Mark G. Stacy who performed labor upon and assisted in pulling green chain, clean-up, and other labor in the manufacture of said lumber for the period of December 3, 1984 through December 20, 1984; and the rendition of said service was closed on the 20th day of December, 1984, and

thirty (30) days have not elapsed since that time; that the amount of claimant's demand for said service is \$647.50 that no part thereof has been paid, and there is now due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of \$647.50, in which amount he claims a lien upon said lumber. The said Mark G. Stacy also claims a lien on all said lumber now owned by said Puget Sound Plywood, Inc. and Horizons Forest Products, Inc., of said county to secure payment for the work and labor performed in cutting and manufacturing the said lumber, herein described.

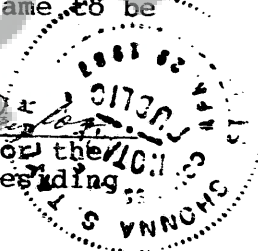
