

son Street in said City;thence running west along the southerly line of Jefferson ~~###~~ Street,one hundred and seventy-five (175) feet ;thence southerly at right angles to the southerly line of Jefferson Street,sixty-seven and thirty-three hundredths (67.33) feet to the southerly line of the donation land claim of A.N.King and Malinda King; thence easterly along the southerly line of said King Donation Land Claim to the north-easterly corner of said lot numbered seven (7) in said block numbered fifty-six (56) in said Carter's Addition;thence northerly along the easterly line of said lot numbered seven (7) and a prolongation thereof to the point of beginning;

22. Also that certain tract of land bounded by beginning on the south line of the donation land claim of A.N.King and Malinda King,at the northwest corner of lot numbered eleven (II) in block fifty-six (56) in Carter's Addition to the City of Portland; thence running easterly along the south line of the said King Donation Land Claim,seventy-five (75) feet;thence northerly at right angles to the south line of said donation land claim,sixty-seven and thirty-three hundredths(67.33) feet,more or less,to the southerly line of Jefferson Street in the City of Portland;thence westerly along the southerly line of said Jefferson Street to a point where the westerly side line of said lot numbered eleven (II),if prolonged northerly,would intersect the same;thence southerly along said westerly line of said lot numbered eleven (II) produced,sixty-three and four hundredths (63.04) feet to the point of beginning;

Also that certain six and one-quarter ($6\frac{1}{4}$) acre tract of unplatted land lying south of and opposite blocks numbered thirty-seven (37) and thirty-eight(38) in Woodlawn,now in and a part of the City of Portland,reference being had to the recorded plats of said Woodlawn,and bounded on the north by Dekum Avenue (formerly Columbia Avenue) in Woodlawn,on the east by a southerly prolongation in its present course of the west line of block numbered thirty-nine (39) in said Woodlawn to the north line of the southwest quarter of section fourteen (14) of township one (I) north of range one (I) east of the Willamette Meridian,on the south by said north line of said southwest quarter of said section Fourteen (14) and on the west by the center line of Union Avenue or a line which is a northerly prolongation of the center line of Union Avenue,together with all machinery,tools,plants,apparatus,buildings and structures now upon said tract of land,including gravel elevators,screens,bankers,electric motor and gravel plant and other tools,machinery and apparatus.

Also blocks numbered seventeen (17) and eighteen (18) in North Mt.Tabor,excepting a parcel thereof beginning at the southeast corner of said block numbered seventeen (17),and running thence north eighty-five and four tenths (84.4) feet;thence west two hundred and twenty-five (225) feet;thence south eighty-five and four tenths (85.4) feet;thence east two hundred and twenty-five (225) feet to the place of beginning;

Also that certain tract of land bounded by beginning at a point in an extension of the west line of that certain forty (40) acre tract of land conveyed by F.F.Gilham to E.S.Larsen,trustee,on the 27th day of January,1890,by deed recorded at page 198 in book 132 in the records of deeds of Multnomah County,Oregon,four hundred and twenty-three and five tenths (423.5)feet south of the northwest corner of said forty acre tract of land,and running thence south along said extended line,one hundred (100) feet; thence east parallel with the center line of villa Avenue,one hundred and thirty (130) feet,more or less,to the center line of Liberty Street,as shown upon the recorded
