Thos.Reath to Hans Nagel

This Indenture Made 4th day of November A.D.1907 between Thomas Reath and Mary M.Reath husband and wife of the County of Skamania State of Washington parties of the first part, and Hans Nagel of the County of Clarke state of Washington, party of the second part, Witnesseth that the said parties of the first part for and in consideration of the sum of two hundred and fifty Dollars to us in hand paid, the receipt whereof is hereby acknowledged, have bargained and sold and by these presents do bargain, sell and convey unto the said party of the second part, his heirs and assigns forever, all the following bounded and described property situated lying and being in the County of Skamania State of Washington, to wit:

The Northeast quarter of Section thirty-two (32) in Township two (2) North of Range six (6) East Willamette Meridian and containing one hundred and sixty acres of land, together with the tenements hereditaments and appurtenances thereunto belonging or in anywise appertaining and also all the estate right title and interest of the said parties of the first part of, in and to the same. To Have and to hold the hereinbefore granted bargained and described premises with the appurtenances, unto the said party of the second part, his heirs and assigns forever. And the said parties of the first part covenant that they are the owners in fee simple of said premises, that we will warrant and defend them against the lawful claims and demands of all persons whomsoever.

This conveyance is intended as a mortgage to secure the payment of the sum of Two Hundred dollars in accordance with the tenor of a certain promissory note of which the following is substantial
