aforesaid lands were acquired by several conveyances and meane conveyances from the Oregon Lumber Company, and all water rights and easements however acquired to said lands appertaining and all property and rights of whatever nature and however acquired belonging to the railway company in the said premises, but subject to the reservations contained in a deed to said premises from John Leland Henderson, Marion I. Henderson, J.F. Short, Eudors Short, John D. Casey, Jennie Casey and David A: McFarland to Tyler Woodward, trustee dated May 19,1903, and recorded on page 443. to 445 in Book "H" of Deeds of said Skamania County,; and

- 78. The southeast quarter of section two (2); and
- 79. The west half of the northwest quarter of section twelve (12); and
- 80. The Southwest quarter of the southeast quarter of section eleven (II); and
- 8I. The north half of the northeast quarter of the northeast quarter of section fourteen (I4); and
- 82. The northwest quarter of the southeast quarter and the west half of the northeast quarter and the northeast quarter of the northwest quarter of section eleven (II), except one (I) acre heretofore deeded to the Order of the Maccabees; and a further grant of right of way for a wagon road and skid road; and.
- 83. That certain portion of section one (I) bounded by beginning at a stake forty-five (45) rods east of the southwest corner of the northwest quarter section one (I), and running thence east twenty (20) rods; thence north eight (8) rods; thence west twenty (20) rods and thence south eight (8) rods to the place of be-ginning; and
- 84. The southwest quarter of the northeast quarter and the northwest quarter # of the southeast quarter of section (I4);
- All in township three (3) north of range nine (9) east of the Willamette Meridian;
- 85. Also all riparian rights and privileges and water rights and privileges and water power rights and privileges and other rights, privileges and appurtenences appertaining to or connected with the above described water power properties and rights, both in the County of Multnomah in the State of Oregon and in the County of Skamanta in the State of Washington;

And also all those certain lines of railway and street railway situated in the city of Portland in the county of Multnomah in the State of Oregon and in the suburbs of said city and the surrounding country in said County of Multnomah, part of thereof being double track lines of railway and part thereof single track lines of railway, laid down and upon the following named street in said city of Portland, and highways, lines and routes, to-wit:

86.
