The Northwest quarter ($\frac{1}{4}$) of the Northwest quarter ($\frac{1}{4}$) and Lot No.eight (8) all in Section One (1),Township Two (2) North of Range Seven: (7) East of the Willamette Meridian,in Skamania County State of Washington,excepting a strip of land three hundfed (300) feet wide on the East side thereof,and also excepting nine (9) acres in the Southeast corner of said tract,heretofore deeded to B.R.Frazier,and also,excepting Five (5) acres on the South side of said tract,deeded to R.L.Nicholson,containing t#twenty-three (23) acres more or less.
