

a general southerly direction passing through Fulton to Riverview Cemetery, and upon Second street from Glisan street to Grant street, and on Second street from Sherman street to Sheridan street, and on Nineteenth street from Glisan street to Morrison street, and upon Morrison street from Nineteenth and Chapman streets to the Willamette river, and upon Yamhill street from Fourth street to Front street, and upon Front street from Morrison street to Yamhill street, and upon Raleigh street from Twenty-third street to Twenty-seventh street, and upon Twenty-seventh street from Raleigh street to Upshur street, and upon Upshur street from Twenty-seventh street to Twenty-fifth street, and upon Eleventh street from Morrison street to Montgomery street, and upon Montgomery street from Eleventh street to Sixteenth street, and upon East Morrison street from the Willamette river to East Twentieth street, and thence continuing in an easterly direction along the south side of Lone fir Cemetery and through Hanson's Addition to and into Belmont street, and thence easterly along Belmont street through Hanson's Second Addition Sunny-side and Bartsch Park and along Rosedale street, Ash street and Fairmount Avenue along the north line of Edendale and Glencoe Park, and along Park street between Mount Tabor Central Park and Belmont Park, and along Nelson street between Mount Tabor central tract and Belmont Villa and through Tabor Heights and East Lynn along Motor Street to a point beyond East View street in Tabor Heights, and upon Grand Avenue between Multnomah street and Ellsworth street, and upon East Ankeny street from Grand Avenue to East Twenty-eighth street, and upon East Twenty-eighth street between East Ankeny street and Weidler street, and upon Holladay Avenue from Grand Avenue to the Willamette river, and upon Multnomah street from Grand Avenue to East Fifteenth street, and upon East Fifteenth street from Multnomah street to Tillamook street, and upon Tillamook street from East Fifteenth street to East Nineteenth street, and upon A street from East Twenty-eighth street to the west line of the Thomas Quinn Donation Land Claim, and thence easterly through the donation land claim of Thomas Quinn and the donation land claim of E.B. Davidson upon or near a line running east and west through the center of section thirty-six (36) of township one north of range one east, and sections thirty-one (31) and thirty-two (32) of township one north of range two east of the Willamette Meridian, and along A street and Villa Avenue to Hibbard street in Mount Tabor Villa Annex, and upon said Hibbard street from Villa Avenue to the base line road, and upon E street in Hawthorne's First Addition between East Twenty-eighth street and Fulton Street, and upon Williams Avenue from Cherry street to Killingsworth Avenue, and upon Quincy street from Cherry street to East First street, and upon East First street from Quincy street to Holladay Avenue, and upon Goldsmith and Larrabee streets from Holladay Avenue to Mississippi Avenue, and upon Mississippi Avenue from Goldsmith street to Prescott street, and on Albina Avenue from Prescott street to Killingsworth Avenue, and upon Killingsworth Avenue from Union Avenue to Greeley street, and upon Greeley street from Killingsworth Avenue to Pippin street, and upon Pippin street from Greeley street to Wabash Avenue, and thence northwesterly to and into Dawson street, and thence upon Dawson street to the northwesterly boundary of said city of Portland, and thence continuing northwesterly along Dawson street and a northwesterly prolongation thereof to Columbia Boulevard, and thence upon Columbia Boulevard to Jersey street in the town of St. Johns in said county of Multnomah, and thence upon said Jersey street to New York street in said town of St. Johns, and thence northeasterly to Depot street in Point View in said county of Multnomah, and thence upon said Depot street its entire length and along a southeasterly prolongation thereof to a point near the south line of section six (6) of township one north of range one east of the Willamette Meridian, and thence southerly and southeasterly to Dawson street in Northern Hill in said county of Multnomah, and upon Stanton street from Williams Avenue to Commercial street, and upon East Harrison street from Grand Avenue to East Twelfth street, and upon East Twelfth street and
