Fullerton to F.E. Bethea

This Indenture Made this 24th day of April in the year of our Lord one thousand nine hundred and eight (1908) between MacArthur M. Fullerton of the first part and F.E. Bethea of the second part; Witnesseth: That the party of the first part for and in consideration of the sum of Twelve hundred and fifty Dollars (\$1250.00) to him in hand paid, the receipt whereof is hereby acknowledged, has bargained and sold, aliened, released, conveyed and confirmed and by these present does bragin sell, alien, release convey and confirm unto the said party of the second part, his heirs and assigns forever, all the following described real property situated in the County of Skamania, State of Washington, to wit:

The South half (S $\frac{1}{2}$) of the Southwest quarter of Section thirty-four (SW $\frac{1}{4}$ of Sec. 34) in Township two (T 2) North of Range five (N of R. 5) East of Willamette Meridian and the Northwest quarter (NW $\frac{1}{4}$) of the Southeast quarter (SE $\frac{1}{4}$) of Section thirty-four (S. 34) in Township two (T. 2) North of Range five (R. 5) East of Willamette Meridian.

Together with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining; and also all the estate, right, title and interest, dower and right of dower, homestead and right thereto, property, possession, claim and demand whatsoever of the said party of the first part of, in and to the same and the reversion and reversions, remainder and remainders, rents, issues and profits thereof. To have and to hold the hereinbefore granted bargained and described premises with the appurtenances unto the said party of the second part his heirs and assigns to his and their own use, benefit and behoof forever.
