Robert Jones to John A. Wilson.

KNOW ALL MEN BY THESE PRESENTS, That I, Robert Jones, the party of the first part, for and in consideration of the sum of Twenty Three Hundred (\$2300.) Dollars in gold coin of the United States of America, to me in hand paid by John A. Wilson, (This is intended to be a partial assignment of said mortgage given as collateral security, to secure the payment of \$1000.) the party of the second part, the receipt of which is hereby acknowledged, have granted, bargained, sold, assigned, transferred and set over, and by these presents do grant, bargain, sell, assign transfer and set over, unto the said party of the second part, a certain Indenture of Mortgage, bearing date the 24th day of January A.D. 1908, made and executed by Rose Shelley and Roswell Shelley, husband and wife, to the said party of the first part, to secure the payment of the sum of Twenty Three Hundred (\$2300.) Dollars together with the Note or obligation therein described, and the money due, or to grow due thereon, with the interest; which said indenture of Mortgage was recorded in the office of the County Clerk of the County of Skamania State of Washington in Vol. G of Mortgages, page 636 on the 27th, day of January A.D. 1908.
