This Indenture, Made this 21st day of August, in the year of our Lord one thousand nine hundred and eight, Between Emma L. O'Bryon, and Geo. E. O'Bryon, her husband, of Stevenson, Washington, parties of the first part, and Bank of Stevenson, a Corporation, of the State of Washington, party of the second part: Witnesseth, That the said parties of the first part, for and in consideration of the sum of Twelve hundred Dollars lawful money of the United States, to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do by these presents Grant, Bargain, Sell, Convey and Warrant unto the said party of the second part, and to its heirs and assigns, the following described tract or parcel of land, lying and being in the County of Skamania, and State of Washington, and particularly bounded and described as follows, to-wit: Beginning at a point 137.6 feet East of the quarter post on South line of Section 36, Township 3 North of Range 7 East of the Willamette Meridian, thence North, 3 degrees 30 minutes West, 321 feet thence South 29 degrees 10 minutes East to a point 159.4 feet East of starting point, thence West along section line to point of beginning."

Also, lots number Four (4), Five (5) and six (6) in Block number Four (4), in Johnson's Addition to the Town of Stevenson, as shown by the dedication and plat thereof now on file in the office of the Auditor of Skamania County, Washington." together with all and singular the tenements, hereditaments and appurtenances thereunto belonging.

This Conveyance is intended as a Mortgage to secure the payment of Twelve hundred Dollars lawful money of the United States, together with interest thereon at the rate of nine per cent per annum from date until paid, according to the terms and conditions of three certain promissory notes bearing date August 21, 1908, made by Emma L.
