Georgia M. Saywers to Malissa J. Shurtleff.

This Indenture, Made this 26th day of August in the year of our Lord one thousand nine hundred and eight Between Georgia M. Saywers party of the first part, and Malissa J. Shurtleff party of the second part: Witnesseth, That the said party of the first part, for and in consideration of the sum of Three Hundred dollars lawful money of the United States, to her in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged does by these presents, Grant, Bargain, Sell, Convey and Warrant unto the said party of the second part, and to her heirs and assigns, the following described tract or parcel of land, lying and being in the County of Skamania and State of Washington, and particularly bounded and described as follows, to wit: Beginning at the Northwest corner of Section Twenty-eight, Township Three North Range Eight East Willamette Meridian, running thence East Thirteen and one third rods, thence South twenty-four rods, thence West thirteen and one third rods, thence North Twenty-four rods to point of beginning, containing two acres.

Together with all and singular the tenements, hereditaments and appurtenances thereunto belonging.

This Conveyance is intended as a Mortgage to secure the payment of Three Hundred Dollars lawful money of the United States with interest thereon at the rate of 10 per cent. per annum from date until paid, according to the terms and conditions of a certain promissory note bearing date Aug. 26, 1908, made by Georgia M.
