This instrument witnesseth that we W. A. Murdoch and May Murdoch husband and wife, W. H. Biggs and M. E. Biggs, husband and wife, David Fulton and Lulu B. Fulton husband and wife, parties of the first part, for and in consideration of the sum of Fifteen Hundred Dollars and in consideration of the covenants, agreements and reservations hereinafter set forth, do by these presents bargain sell and convey unto W. O. Hadley and S. S. Hayes, parties of the second part, their heirs and assigns the following described real property, to-wit:

All the certain lot piece or parcel of land situated lying and being in the State of Washington, County of Skamania, and bounded and particularly described as follows: Being a part of the Donation Land Claim of James M. Findlay and wife and bounded as follows: Beginning at the south west corner of said Findlay claim running thence north forty (40) chains to the north west corner of said claim thence east ten (10) chains to the stake, thence south forty (40) chains to the Columbia, thence westerly by said river to the place of beginning containing forty (40) acres more or less. Together with all and singular the tenements, hereditaments and appurtenances thereto belonging or in any wise appertaining. To have and to hold all and singular the said premises together with the appurtenances unto the said parties of the second part their heirs and assigns forever. Nevertheless the said parties of the first part reserve for themselves during the rest of their lives the right respectively to enjoy the use of a camping place on said land the same to be chosen by the said parties of the first part, also the said parties of the first part are hereby given and granted the privilege, and they reserve the same, of bathing in Hollens Spring, which is situated on or near said land, and in enjoying the use of the waters and baths of said spring for bathing purposes in a reasonable manner.
