

the Northwest corner stake, thence in an Easterly direction 1500 feet to the Northeast corner stake, thence in a Southerly direction 300 feet to the place of beginning.

XIII. The Chattanooga Lodge Discovery claim No 1 Southeast, beginning at the Discovery, witness a Discovery stake, which is about 1000 feet in an Easterly direction from the Valley of the North Fork River and about 300 feet west of Goat Lake and on a small stream which heads in said lake and about 1500 feet south of Goat lake Creek and about 200 feet Northeast of the Iron Head Discovery, running from said Discovery stake 300 feet in a South westerly direction to the Southwesterly corner stake, thence in a Southeasterly direction 1500 feet to the Southeasterly corner stake, thence in a Northeasterly direction 600 feet to the North easterly corner stake, thence in a Northwesternly direction 1500 feet to the Northwesterly corner stake, thence 300 feet in a Southwesterly direction to the place of beginning.

XIV. The Chattanooga claim Discovery claim No. 2 Northwest, beginning at the Chattanooga Lodge Discovery claim No 1 Southeast, as designated in the thirteenth paragraph herein, and running from said Discovery point 300 feet in a southwest direction to the Southeasterly corner stake, thence in a Northwest direction 1500 feet to the Southwesterly corner stake, thence in a Northeasterly direction 600 feet to the Northwesterly corner stake, thence in a Southeasterly direction 1500 feet to the North easterly corner stake, thence in a Southwesterly direction 300 feet to the place of beginning.

XV. The Box Canyon Lodge, Discovery claim No 1 West, beginning at the Discovery, which is at the base of Box Canyon Falls, on the Southwest Slope of the Strawberry range of mountains and on Box Canyon Creek about one half Northeast of its junction with the North Fork River, from said Discovery running in a Southwesterly direction 300 feet to the Southeast corner stake, thence 1500 feet in a westerly direction to the Southwest corner stake, thence in a Northerly direction 600 feet to the Northwest corner stake, thence in an Easterly direction 1500 feet to the Northeast corner stake, thence in a Southerly direction 300 feet to the place of beginning.

XVI. The Box Canyon Lodge, Discovery claim No. 2 East, beginning at the Discovery of the Box Canyon Lodge, Discovery No 1 West as designated in the fifteenth paragraph herein and running from said Discovery in a Southern direction 300 feet to the Southwest corner stake, thence in an Easterly direction 1500 feet to the Southeast corner stake, thence in a Northerly direction 600 feet to the Northeast corner stake, thence in a Westerly direction 1500 feet to the Northwest corner stake, thence in a Southern direction 300 feet to the place of beginning.
