Moore to Wing Marble

The Mortgagors, C.J. Moore and J.E. Moore (husband and wife) mortgage to H.E. Wing Marble the following real estate situated in the County of Skamania, State of Washington, to-wit:
Commencing at a point ^{twenty} seven and fifty hundredths (27.50) chains from the southwest corner of Section seventeen. (17) Township One (1) North of Range ^{five} (5) East of Willamette Meridian, running thence North twenty four (24) chains to a point twelve and fifty hundredths (12.50) chains west of the North and South line through the center of said section seventeen, thence west twelve and fifty hundredths (12.50) chains to said North and South line, thence South twenty four (24) chains to the quarter post upon the South side of said section seventeen, thence West twelve and fifty hundredths chains to the place of beginning, containing thirty (30) acres., to secure the payment of the sum of Sixteen hundred (\$1600) dollars and the interest thereon, in accordance with the tenor of a certain promissory note of which the following is a copy to-wit:

\$1600.00 Washougal, Wash December 15th 1908

On or before five years after date for value received, we promise to pay to the order of H.E. Wing Marble Sixteen hundred dollars with interest thereon payable annually at the rate of six per cent per annum from date; and if not so paid the whole sum of both principal and interest to become immediately due and collectable at the option of the holder of this note. If the interest is not paid when due it shall be compounded with the principal and bear like interest, principal and interest payable in U.S. Gold Coin, and in case suit is instituted to collect this note or any portion thereof, we promise to pay such additional sum as the Court may adjudge reasonable as attorneys fees to be taxed as a part of the costs of such suit, for the use of plaintiffs attorney.
