Know all Men by these Presents: That Catherine Haffey, widow of William Haffey deceased, James Haffey, William Haffey, Bernard Haffey and Clarice Haffey, his wife, John Haffey and Lulu Haffey, his wife, and Cornelius Haffey, residents of the County of Skamania, State of Washington, in consideration of one Dollar (\$1.00) and other considerations, do hereby convey and quit claim unto Frank Haffey all our interest in the following bounded as is and described real estate situated in said Skamania County, State of Washington to-wit:

Commencing at the Southwest corner of that portion or tract of land containing nearly two and one third (2-1/3) acres, heretofore set apart or apportioned out of the real estate of the Estate of William Haffey deceased to Catherine Haffey, widow of said William Haffey deceased, on the South line of said Estate running thence North along the West line of said portion of real estate so set apart or apportioned to Catherine Haffey, as aforesaid, one hundred and sixty (160) rods to the North line of said estate, thence West along said North line fifteen (15) rods and twenty (20) links, thence South parallel with said West line one hundred and sixty (160) rods to the South line of said Estate, thence East along the said South line of said Estate to the place of beginning.
