Know all Men by these Presents That E.S. Gillis and Mattie Gillis his wife the parties of the first part, for and in consideration of the sum of Two Thousand (\$2000.00) Dollars, Legal tender of the United States of America, to us in hand paid by John Asher of Camas, Washington the party of the second part, the receipt whereof is hereby acknowledged, have granted, bargained, sold, assigned, transferred and set over, and by these presents do grant, bargain, sell, assign, transfer and set over unto the said party of the second part, a certain Indenture of Mortgage, bearing date the 16th day of July one thousand nine hundred and eight made and executed by Wm. S. Harvey and Emma Harvey his wife to E.S. Gillis and Mattie Gillis his wife to secure the payment of the sum of thirty three hundred (\$3300) Dollars, together with the note or obligation therein described, and the money due, or to grow due thereon, with the interest; which said Indenture of Mortgage was recorded in the office of the County Auditor of Skamania County, State of Washington, in Book H of Mortgages, page 250 on the 20th day of July 1908.

To Have and to Hold the same unto the said party of the second part his executors, administrators and assigns, for their use and benefit; subject only to the proviso in the said Indenture of Mortgage mentioned. And the said parties of the first part do hereby make, constitute and appoint the said party of the second part his true and lawful attorney, irrevocable in _____ name or otherwise, but at the proper costs and charges of the said party of the second part, to have, use and take all lawful ways and means for the recovery of the said money and interest; and in case of payment to discharge the same as fully as the said parties of the first part might or could do if these presents were not made.
