Know all men by these presents that I, Gus A. Lovegren, the party of the first part, for and in consideration of then sum of eight hundred and fifty (\$850.00) Dollars lawful money of the United States to me in hand paid by H.E. Noble, the party of the second part, the receipt whereof is hereby acknowledged, have granted, bargained, sold, assigned and transferred and set over and by these presents do grant, bargain, sell assign, transfer and set over unto the said party of the second part, a certain Indenture of Mortgage bearing date the 21st day of December 1908 made and executed by Joseph B.
