

Sara Jane Whitney to David C. Whitney et al.

Know all men by these Presents: That I, Sara Jane Whitney, of the city of Detroit, County of Wayne and State of Michigan, the widow of David Whitney, Jr. late of said City, deceased, in consideration of one Dollar and other valuable considerations to me paid by David C. Whitney and Charles Stickfield, trustees under the last will and testament of said Deceased and under a certain agreement of family settlement, executed by me and by the heirs of said Deceased, bearing even date herewith, the receipt of which considerations is hereby acknowledged, have granted, renewed, released, conveyed and forever quit-claimed, and by these presents do grant, demise, release and forever quit-claim unto the said David C. Whitney and Charles Stickfield, as Trustees aforesaid, and to their successors and assigns forever, all the Dower and Thirds, right, title, interest and title of Dower and Thirds and all other right, title, interests, property, claim and demand whatever in law or in equity which I may have in and to all and every the lands, tenements and real and personal estate whereof the said David Whitney Jr., died seized or possessed or wherof he was seized or possessed at the time of his intermarriage with the said Paris Davis Whitney, or at any time since, wheresover the same may lie and be situate, except the legacies bequeathed to me by the said Deceased in his last will and testament, and the right to occupy and use the homestead, number eight hundred and thirty-five Woodward Avenue, in the city of Detroit, with the barn and other appurtenances thereto belonging, as provided in the aforesaid will, so that neither I, the said Sara Jane Whitney, my heirs, executors, administrators or assigns or any person or persons for me, them or any of them, shall have claim, or demand any other Dower or Thirds or any other right, title, claim or demand of, in or to the same or any part thereof, but thereof and therefrom shall be utterly barred and excluded forever.
